Minutes Approval: Ted moved that Minutes for the May 11th meeting be approved. Ginny seconded the motion. Minutes were approved.

Treasurer's Report:

- The May financial reports were reviewed and discussed. Checks were reviewed and signed. Jeannine sought approval from the Board to transfer the remaining \$25,000, budgeted to come From Committed Funds. Approval granted.
- There was a motion to approve by Brent and seconded by Ted. Motion Passed.

Office Managers Report:

- LPEA ballot was discussed and voted on. Jeannine will mail it.
- The 2020 Audit is still out. Todd Beckstead said he hopes to have it ready by the end of June.
- A commemorative plaque for Station 1, was discussed.

Fire Chief Report-Out:

- Chief reported on the Resource Order; B-71 (013) (staffed with 2
 Volunteers/daily, several volunteers have signed up); 30 days, thru July 6th,
 with the Southern Ute Tribe; Chief expects there will be a follow-on order.
- There were 4 interested in the Seasonal Hire advertisement that was circulated internally. There applications were reviewed by the Board later in the meeting. The results were: All four applications were accepted, as they had acknowledged the position might be shared, 4-days/week. Funding coming from Scheduled Shifts funds.
- Chief will present proposal for enacting Stage 1 fire restrictions to the La Plata County Board of County Commissioners on Tuesday, June 15th. He informed that the county is in the same position it was in, for moisture levels, 3 yrs. ago when the 416 fire was burning.
- PPE was acquired through donation from the Southern Utes. He feels there is good interaction between the two agencies.
- Masks and eye shields are now more commonplace. Debbie suggested it be communicated within the District, to wear or not to wear masks, is acceptable.
- 27 volunteers on roster; 9 largest response in Apr; 22 in the rolling quarter;
 9 certified EMT's; 1 to Board test; 78 calls YTD; Jessica Lee has turned in gear and will come off the roster.
- Chief expects Station 1 to be occupied by week of June 14th. Becoming more operational.
- He expressed appreciation for the countless hours donated to work on Station 1 by Ted & Donna Stahl, and many others as well.
- Station 6 water tanks and hydrants work scheduled for Aug/Sep.
- The Repeater Site will be re-keyed and graveled.
- There were 6 CPR cards from a class, issued.
- Station Saturday cancelled but plenty of opportunity to learn and train.

Coming up:

- Tri State team training- 4 people committed; 2 more needed. Competition/Training will be August 6-7th.
- FLMFPD Picnic July 24th @ 6:00pm.
